## GUIDELINES/REGULATIONS FOR AIMART REALTORS CONSULTANTS

IN THIS GUIDE LINES BELOW, WE HAVE 4 DIFFERENT LEVELS OF CONSULTANTS WHICH INCLUDE: THE ORDINARY MEMBER, THE SILVER MEMBER, THE GOLD MEMBER AND THE PLATINUM MEMBER. KINDLY GO THROUGH IT TO KNOW THE ONE YOU WOULD WANT TO REGISTER AS.

1. WE HAVE A MEMBERSHIP FEE OF N1, 500 FOR REGISTRATION. HERE THE COMMISSION LEVEL WILL BE 10% ON DIRECT SALE AND 3% ON INDIRECT SALE.
2. PARTNERS MEMBERSHIP FEE IS TO BE PAID FOR YOUR REGISTRATION PACK AT THE RATE OF N25, 500, WHICH WILL MAKE YOU A PARTNER TO THE COMPANY AND YOU WILL BE ENTITLED TO YOUR OWN CUSTOMIZED FLIERS, BOTH HARD AND SOFT COPY, BUSINESS CARDS, A T-SHIRT, A CAP, AN ID CARD and AN ADVANCE TRAINING. COMMISSION BASE LEVEL IS 15% ON DIRECT SALES ONLY.
3. ALL MEMBERS WILL ENJOY SPA SESSION FOR TWO AT SUNFIT SPAS AFTER EVERY FIVE SALES.
